Advocacy Digest | March 19, 2025 Brad Boycks, Executive Director



Governor Tony Evers introduced his proposed 2025-2027 state budget on February 18, outlining a spending plan totaling \$118.9 billion. The proposal also calls for adding 881 full-time state government positions. For comparison, the last two-year state budget came in at \$97.4 billion and reduced the number of full-time state employees by 176.

Tax Provisions and Local Government Aid

One of the key highlights in Evers' proposal is a \$2 billion tax reduction plan, along with \$1.1 billion in aid to local governments and direct property tax credits aimed at holding the line on property taxes. However, the budget also introduces a new top income tax bracket of 9.8% for individuals and married joint filers earning over \$1 million.

Other notable tax-related provisions include:

- Eliminating sales tax on residential electricity and gas from May to October.
- Providing \$226 million for a new county and municipal property tax freeze incentive program.
- Allowing counties (excluding Milwaukee County) to impose an additional 0.5% sales tax if approved by local referendum.

Allowing municipalities with populations over 30,000 (excluding Milwaukee) to

impose a 0.5% sales tax via referendum.

Agency-Specific Highlights

Several key agencies would see notable changes under the proposed budget:

- Department of Safety and Professional Services (DSPS): Would receive 10 additional positions for credential processing, 14 positions for occupational licensing assistance, and four new legal support staff positions.
- Wisconsin Housing and Economic Development Authority (WHEDA): Increases state housing tax credits from \$42 million to \$100 million and modifies recently passed workforce housing loan programs.
- Department of Administration (DOA): Includes \$20 million for a local zoning incentive pilot program designed to encourage zoning changes that facilitate affordable housing development. An additional \$1 million would be allocated to local programs focused on building or remodeling affordable housing.
- **Disaster Preparedness:** A new program under the Office of the Commissioner of Insurance would allow for the creation of tax-free "catastrophe savings accounts" to help homeowners cover repairs following major disasters.
- Consumer Protection: The Department of Agriculture, Trade, and Consumer Protection would gain new authority

to prevent price gouging by residential contractors, tree trimmers, and mitigation service providers operating in stormaffected areas.

Department of Natural Resources

(DNR): Would require additional safety measures for retention ponds located in areas with a population density of at least 1,000 people per square mile.

What's Next?

The Legislative Fiscal Bureau is expected to release plain-English summaries of the budget by mid-March. After that, the Joint Committee on Finance will begin agency briefings, during which state officials will answer questions about the proposal.

The next step will likely involve public hearings, followed by the finance committee crafting its own version of the budget. Given Republican control of the committee, it is widely expected that they will start from a base budget and remove many, if not all, of Governor Evers' proposals. Some non-policy provisions could be reintroduced during the budget negotiation process.

Historically, both the legislature and the governor have aimed to pass and sign the state budget into law before the July 1 deadline. We'll continue to monitor the process closely and keep you updated on key developments.


